Deportations Afghanistan

Arrangement with Taliban via Qatar. Meant as a proof of anti-migrant policy, and also as a threat to refugees from Afghanistan to stay calm.

At same time delaying the reception of Afghani people stuck in Pakistan. Only 47 persons came this month, after reaching a court decision.

The ministry of Interior has now even started direct negotiations with the Taliban. The BMI wants regular deportations, with Scheduled flights, not only with Charter flights.

These persons, criminals or not, are being de-humanized for political propaganda.

The situation of these persons is highly difficult.

Even IOM does not support these deportations. Frontex not involved.

Border controls continuing

Controls at the Schengen borders prolonged until March 2026

Number of Asylum Application decreasing by 50%, and Dobrindt claims this is result of Border Controls.

However, the main reason is decreasing number of refugees from Syria, and

Controls at the Polish border to Belarus. There are less refugees coming, everywhere in Europe.

Still, Government is selling these figures as a result of their policy. This is not fact, but it helps them to try to prove efficiency, in competition with the extreme right.

This is also the reason of the deportations to Afghanistan. And, as they say, they intend to reduce the "pull factors" for refugees. This means deteriorating living conditions, and things like the new Bezahlkarte (no cash for Refugees).

Also 3 y break of family reunification.

Any resistance?

I will talk about this a bit later. The main opposition to the border controls, at the moment, comes from GdP, because of too many surplus-hours.

Another form of resistance comes from refugees and migrants: Those whom they want for the labour market, they are also searching for other destinations. They are heading for Spain, and other destinations.
